### A Message from Leadership...

Aging Care Connections is pleased to announce our organization has expanded our program offerings. AgeOptions, our Area Agency on Aging, has awarded Aging Care Connections the grant award to provide comprehensive caregiver support to caregivers residing in Lyons, Riverside, Proviso, Leyden and Norwood Park Townships beginning October 1, 2013. Aging Care Connections appreciates the confidence expressed by AgeOptions in the expansion of our current grant. Caregiver support is funded through the Older Americans Act under Title III-E; Area Agencies around the country are responsible for selecting provider agencies and establishing what services are funded through this grant.

The Caregiver Support program in suburban Cook County consists of one-on-one counseling and support for caregivers caring for an older adult or grandchild; support groups; respite care and educational programs. Aging Care Connections will be working with approximately twice the geographic area and twice the number of potential caregivers we currently served in the expanded area. According to the U.S. Census completed in 2010, the number of adults older than the age of 65 with some limited ability to manage daily activities is more than 9,000 in these five townships. Clearly, there will be many challenges as we expand the service area. However, Aging Care Connections has been providing Caregiver Support since 1997 beginning with a grant project funded by the Community Memorial Foundation. Our Caregiver Specialist, Ruth Folkening has been leading the Caregiver Program at Aging Care Connections for several years and brings a wealth of experience and insight into the issues that confront caregivers each day.

Aging Care Connections approaches the expansion of our grant award with three major goals: quality programs and service to caregivers throughout the area, intensive outreach and education in Proviso, Leyden and Norwood Park Townships to be sure that caregivers residing in these areas are aware of the resources available through the caregiver project, and lastly, to work with the established community providers to offer coordination of resources and all community assets in order to best serve caregivers. We invite any suggestions and feedback as we move forward in this exciting project.

Effective October 1, Aging Care Connections will add Salerno's **Congregate Dining Program** to its comprehensive range of programs and services. We will assume responsibility for the daily operation and administration of the program in cooperation with the Village of Hodgkins. We look forward to offering benefits assistance, health and wellness and educational programming in what will be an outpost location for our organization. We are gratified to sustain this important program for seniors.

Finally, we have been given the grant award to be designated as an **Aging and Disability Resource Network Agency** to older adults and individuals with disabilities aged 18-59 in Norwood Park Township communities. We will offer information, referral and assistance, including options counseling and benefits assistance.

We wish to thank AgeOptions for the opportunity to meet these new challenges. We approach each with a long history of excellence in delivering quality services to seniors. #### HOME ENERGY BILL PAYMENT ASSISTANCE

## LIHEAP DIRECT VENDOR PAYMENT

LIHEAP DVP is designed to assist income-eligible households with energy services, in the form of a one-time benefit payment to the utility companies that is applied directly to the household's energy bills. The amount of the payment is determined by income, household size, and fuel type.

## LIHEAP PERCENT OF INCOME PAYMENT PROGRAM

LIHEAP PIPP provides a monthly benefit payment to the utilities based on household utility usage and monthly income. Customers are required to pay a reduced amount on their utility bills each month to get the benefit payments. PIPP participants who make their utility payments on time will receive credits towards their outstanding balance. Disconnected households are not eligible.

- Applicants that have their utilities included in the rent must bring copy of rental agreement which states monthly rental amount, that utilities are included, and landlord contact information. (Rent costs must be greater than 30% of household gross income for 30 days prior to application.)
